MEMORANDUM OF UNDERSTANDING (MOU)

This **MEMORANDUM OF UNDERSTANDING (MOU)** is entered into on the by and between **Edureka, RR Nagar, Bangalore (here in after referred to as “Edureka” located at Bangalore, Karnataka and ACS College Of Engineering, Bangalore, (here in after referred to as “ACSCE”) located at Bangalore, Karnataka.**

WHEREAS **Edureka** and **ACSCE** wish to work together to provide Computer science courses for student’s skill development and encourage quality in learning so that the students which they serve may make the most meaningful contribution to society through the maximization of their individual personal potentials and achievements.

NOW THEREFORE THIS MEMORANDUM OF UNDERSTANDING WITNESSES AS FOLLOWS:

RESPONSIBILITIES

To achieve the objectives set out above the parties carry out the following activities and the collective responsibilities

1. Edureka:

- i. Provides computer science courses for ACSCE students.
- ii. Mentoring students in ACSCE.
- iii. Assist with programs in several skill and capacity building areas benefiting ACSCE students.

- iv. Facilitate to conduct seminars, workshops, training programs, demonstrations etching the existing infrastructure. A nominal fee shall be collected from the first party for these activities.

2. ACSCE:

ACSCE shall create awareness amongst its students for promotion of the activity especially Computer science courses training program.

TERMS OF MOU

This MOU shall be operational and valid from 1st December 2023 to 1st December 2024. After one-year tenure with the ACSCE, we can extend the agreement for 3 (Three) years. Upon completion of the one year, the agreement can be renewed with mutual consent of both parties.

CERTIFICATION

Upon completion of the Computer science courses training, EDUREKA will conduct assessment for students. The students qualifying the assessment shall be certified with completion certificate.

RELATIONSHIP

This MOU relates solely to the intention of the parties, wherein ACSCE and EDUREKA and shall not extend to any other activity or create a partnership between the Parties here to and under any law of any country. The parties agree that it is not their intention to share any loss or profit between them in the irrespective fields, except to the extent especially provided here in.

COSTS

1. EDUREKA and ACSCE agree that all costs associated with specific training initiatives will be the subject matter of separate contracts.
2. Cost to all Training activity to be borne by per student basis through ACSCE.

CONFIDENTIAL AND PROPRIETARY INFORMATION

1. "Confidential Information" shall mean all information, including the course material and other information if any so given to **ACSCE**, written or verbal, identified as confidential or of a nature that a reasonable person would understand as being considered confidential by **EDUREKA** and disclosed by **EDUREKA** to **ACSCE** or its faculty which is related to **EDUREKA** information such as course material, training data, guidance notes, procedures, methodology, etc

2. **ACSCE** shall hold in trust and confidence for **EDUREKA** all confidential information provided by **EDUREKA** and **ACSCE** shall not disclose to any Person or use such information for any purpose other than defined in this MOU. **ACSCE** shall not make any copies of the confidential information other than are required for the work involved and with prior and mutual consent from **EDUREKA** and shall return/destroy all such information at the termination of the contract. By disclosing this information to **ACSCE**, **EDUREKA** does not grant any expressed, implied or other license or right to **ACSCE** to propagate the information. **EDUREKA** hereby grants to **ACSCE** an academic, non-exclusive, non-transferable right solely for the purpose of providing Computer science courses training to the **ACSCE** students.

3. **ACSCE** shall not disclose **EDUREKA** confidential information and Brand name without first obtaining written consent from **EDUREKA**.

4. **ACSCE** shall disclose **EDUREKA** confidential information only to **ACSCE** employees having a legitimate reason to know the same and shall inform each employee receiving the confidential information of the confidential nature of the same and **ACSCE** obligations here under.

5. **ACSCE** shall secure documents, items of work in progress and work products that embody confidential information in locked files or are as providing restricted access to prevent its unauthorized disclosure. **ACSCE** shall maintain adequate procedures to prevent loss of any confidential information or confidential documents provided to it by **EDUREKA**. In the event of any loss, **ACSCE** shall notify **EDUREKA** immediately.
