ANTI-RAGGING POLICY

1. INTRODUCTION

Dr. A.C.S. College of Engineering is committed to providing a safe, inclusive, respectful, and conducive learning environment for all students. The institution believes that education flourishes in an atmosphere of mutual trust, dignity, discipline, and ethical values. Ragging, in any form, is a serious violation of human dignity and institutional discipline and is strictly prohibited.

The College adopts a **Zero Tolerance Policy** towards ragging in accordance with the **University Grants Commission (UGC) Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009**, AICTE guidelines, the directions of the Hon'ble Supreme Court of India, and Government of Karnataka regulations.

Every student admitted to the College is entitled to study in an environment free from fear, harassment, humiliation, intimidation, or exploitation. The College shall take all necessary preventive, monitoring, and disciplinary measures to ensure a ragging-free campus.

2. OBJECTIVES OF THE POLICY

The objectives of this Anti-Ragging Policy are to:

- Promote a healthy academic environment based on mutual respect and discipline.
- Ensure the safety, dignity, and well-being of every student.
- Facilitate smooth social and academic integration of newly admitted students.
- Prevent all forms of ragging within the campus, hostels, transportation, and off-campus activities.
- Encourage students to report incidents without fear of retaliation.
- Establish transparent procedures for complaint handling and disciplinary action.

- Create awareness among students, parents, faculty, and staff regarding anti-ragging regulations.

3. SCOPE

This policy applies to:

- All undergraduate, postgraduate and research scholars.
- Day scholars and hostel residents.
- Students participating in internships, industrial visits, educational tours, sports, cultural activities, and other College-sponsored events.
- All locations including classrooms, laboratories, library, hostels, canteen, buses, playgrounds, parking areas, and areas surrounding the campus.

4. DEFINITION OF RAGGING

Ragging includes any act by one or more students, whether by words, actions, gestures, written communication, electronic communication, or social media, which has the effect of:

- Teasing, insulting, or humiliating another student.
- Causing physical or psychological harm.
- Forcing a student to perform acts against his/her will.
- Creating fear, embarrassment, or mental trauma.
- Physical assault or abuse.
- Verbal abuse or obscene language.
- Sexual harassment or misconduct.
- Financial extortion or forced expenditure.
- Exploitation of junior students for personal work.
- Cyber ragging through social media, messaging platforms, emails, or digital communication.
- Any activity disrupting the academic or personal life of another student.

Ragging in any form is strictly prohibited both inside and outside the College campus.

5. PREVENTIVE MEASURES

To maintain a ragging-free environment, the College shall implement the following preventive measures:

5.1 Awareness Programmes

- Orientation programmes for fresher and parents.
- Awareness sessions regarding UGC Anti-Ragging Regulations.
- Distribution of Anti-Ragging guidelines during admission.
- Display of anti-ragging posters throughout the campus.
- Publication of anti-ragging information on the College website.

5.2 Student Undertakings

Every student and parent/guardian shall submit:

- Online Anti-Ragging Affidavit.
- Signed declaration confirming compliance with UGC Anti-Ragging Regulations.

5.3 Mentoring System

Each first-year student shall be assigned a faculty mentor to provide academic guidance, emotional support, and assistance during the transition into college life.

5.4 Interaction Programmes

The College shall organize:

- Freshers' Orientation Programme
- Mentor-Mentee Meetings

- Student Club Activities

These programmes are intended to promote healthy interaction between senior and junior students.

6. ANTI-RAGGING COMMITTEE

The Committee shall:

- Review implementation of Anti-Ragging Policy.
- Conduct periodic meetings.
- Investigate complaints.
- Recommend disciplinary action.
- Submit compliance reports to competent authorities.

7. ANTI-RAGGING SQUAD

The College shall constitute Anti-Ragging Squads consisting of faculty members and staff.

The Squad shall:

- Conduct surprise inspections.
- Monitor vulnerable areas.
- Interact with students regularly.
- Prevent ragging before it occurs.
- Immediately report incidents to the Principal.

9. COMPLAINT MECHANISM

Any student may report ragging through:

- UGC National Anti-Ragging Helpline

Complaints may be submitted:

- In writing
- Through email
- In person

- Through parents or guardians

The identity of the complainant shall be kept confidential to the maximum extent possible.

10. ENQUIRY PROCEDURE

Upon receiving a complaint:

- Preliminary enquiry shall commence immediately.
- The Anti-Ragging Committee shall investigate the matter fairly.
- Both complainant and accused shall be given an opportunity to present their case.
- Confidentiality shall be maintained.
- Recommendations shall be submitted to the Principal for final action.

11. DISCIPLINARY ACTION

Depending on the gravity of the offence, one or more of the following penalties may be imposed:

- Warning
- Written apology
- Fine
- Community service
- Suspension from classes
- Withholding scholarships or fellowships
- Debarring from examinations
- Debarring from placement activities
- Suspension from hostel
- Cancellation of admission
- Rustication

- Expulsion from the College
- Filing of FIR with Police
- Criminal proceedings under applicable laws

The decision of the Principal shall be final, subject to applicable rules and regulations.

12. RESPONSIBILITIES OF STUDENTS

Every student shall:

- Treat fellow students with dignity and respect.
- Refrain from participating in ragging directly or indirectly.
- Report any incident of ragging immediately.
- Cooperate during enquiry proceedings.
- Follow all College rules and UGC regulations.

Failure to report ragging may also attract disciplinary action.

13. RESPONSIBILITIES OF FACULTY AND STAFF

Faculty members and staff shall:

- Maintain constant vigilance.
- Guide and counsel students.
- Report suspected incidents immediately.
- Participate in awareness programmes.
- Support implementation of preventive measures.

This policy shall be reviewed periodically by the College Management and Anti-Ragging Committee to ensure compliance with the latest UGC, AICTE, VTU, and Government regulations.
